Waste

At the beginning of this year, the municipality of Wassenaar removed all Plastic Metal and Beverage Packages (PMD) containers. This is because residents are allowed to throw PMD and residual waste in one bin from January. The residual waste bin is therefore emptied weekly. From this year on, the green waste will be collected once every 2 weeks. Note: The bin will not be emptied more frequently in the spring and autumn. You can request an extra green waste bin from the municipality for €50 if needed.

Traffic

A lot has happened in the field of traffic in Wassenaar in recent months. Emotions ran high. On December 14, the city council finally decided that the downgrade of (only) Jagerslaan to a 30 km road will be removed from the new plan and integrated into a new and broader study into the possibility of introducing a 30 km speed limit. For the whole of Wassenaar (or around the center, eg from north to Papagaaienlaan) in imitation of other cities and national policy. The alderman will come up with an action plan for the new investigation before March 1st 2022. This investigation must be completed bv September 1st and presented to the council. The project Renovation of the Prinsenweg will also start in 2022. The intention is to provide the road with low-noise asphalt and also to make it safer for cyclists and pedestrians. The start of work at the end of 2022/beginning of 2023 must be taken into account. The project is radical and will last approximately one year.

Zorgcampus 2

We have previously informed you that we as a board have expressed our concerns and have drawn attention to the future parking and traffic problems surrounding the new building, but unfortunately without result. The objections submitted by local residents have been rejected. The intended date to start the demolition is early March 2022. The demolition will take approximately 4 to 5 months. Ad Hoc's management of this location will stop at the end of February and the location will then be completely fenced off. The street behind "het Elzenlaantje" is closed for safety.

In the second half of February, the Hanselman expert bureau will be recording immediately surrounding homes. The homes that qualify for this will receive a letter. The contractor who will carry out the demolition is Knijnenburg from The Hague. This contractor also demolished the first phase at the time. The existing entrance on Poortlaan is used for cars belonging to employees of the demolition company. The existing entrance on Ridderlaan is used for heavier construction traffic.

The supply and discharge route for heavy traffic will be Rijksstraatweg > Lange Kerkdam > Prinsenweg > Van Zuylen van Nijveldstraat > Storm van S-Gravensandeweg > Ridderlaan and vice versa. Points of attention that we have given to the demolition contractor, among other things, is bringing children from the Montessori school to the Zanderijpad.

Fonds Wassenaar

Warenar

In January 2020, the city council gave the order to retain the theater De Warenar and to add the village hall function to it, to make the building more sustainable and to conduct a feasibility study into adding homes.

The parish has entered into a letter of intent with the municipality of Wassenaar and the Beheer Warenar foundation to further develop the sale of the property and the development of homes.

On July 9th 2021, the Diocese of Rotterdam has authorized the parish to sign the letter of intent and to continue the process for the sale of De Warenar. The building will retain a social and cultural interpretation in the future. The parish has also expressly included in the letter of intent that a parish hall be realized at the De Warenar building, for which it is being investigated to what extent the residential house of Heeckerenstraat 9 is suitable for this or can be expanded.

In this process, the municipality will mainly test to what extent the added and existing functions in and around the De Warenar building remain in proportion to the monumental character of the building and its surroundings.
